

MEMORENDUM of AGREEMENT

Partnership agreement between Lycée Jules Lesven and Fereikos

The agreement is made and entered into by and between:

the **Lycée Général, Technologique et Professionnel Jules Lesven**, herein referred to as «Lycée Jules Lesven», 34 rue Jules Lesven, BP 72507, 29225 BREST Cedex 2, FRANCE

and:

Fereikos Snail Products, herein referred to as «commercial partner», 20011 Glyfada, Archea Korinthos/ Ancient Corinth, GREECE.

Fereikos is a Greek company specialising in snail farming services & the export of snail products. It is represented by Ms Maria Vlachou, CEO/ Managing director.

The Lycée Jules Lesven, through its BTS Commerce International course, aims at training students for various careers in international trade. It is represented by its headmaster, Mr Stéphane Revelen.

In consideration of the mutual promises set forth herein, the parties agree as follow :

Article 1: the context

The Lycée Jules Lesven wishes to develop and formalize the relationship between the school and its commercial partner through this partnership agreement.

The framework of the course stipulates a placement carried out abroad lasting eight weeks / two months and the Lycée Jules Lesven and its commercial partner jointly wish to favour the students' training and professional integration.

The agreement aims at creating favourable conditions for an efficient collaboration between the company and the school.

Article 2: objectives

The partnership will consist in :

- meeting the temporary needs of the company by supplying trainees in May and June, i.e. at the end of the first academic year, within the framework of a training agreement signed between the company and the school
- providing the students with a placement focusing on clients' prospection
- informing the partner regarding possible technological, economic or organisational evolutions that may arise
- providing information that may help the partner in its activity
- arranging possible visits of the company by the students and teachers in charge

Article 3: communication

Regular exchanges will take place by means of phone calls, emails or possible meetings.

Article 4: duration

The agreement will come into effect from the date of signing and will be tacitly renewed in the absence of a cancellation notice addressed by either of the parties.

Article 5: amendments and modifications

Amendments and modifications may occur in agreement with the partners and depending on the evolution of the partnership.
